

- ~300 checklists covering the most common reasons patients present to primary care





BREAKDOWN ACCESS BARRIERS AND GET TIME SPECIALTY CARE FOR ALL

- Access to specialists in over 70 disciplines, including 16 pediatric sub-specialties, means your patients don't have to wait for weeks to find an office that accepts Medicaid.
